The funds provided will assist the Cherokee County Family YMCA as we continue to meet the physical, social, and emotional needs of the citizens of Cherokee County. Physical activity is a key part of maintaining and improving health and the Y offers a wide variety of accessible, affordable programs that encourages people throughout Cherokee County to exercise and live a healthier lifestyle. These initiatives will help people improve their physical and mental health as well as support physical renovations and additions to the YMCA's facility that will help programming across the board. The auxiliary gym will provide much needed additional space for youth sports and programming. As participation grows in our youth sports leagues (ie: basketball) and our childcare programs, additional space will allow us to better accommodate the participants. A new auxiliary gym will also provide the YMCA with an opportunity to expand on existing programs like pickleball. Cherokee County is projecting substantial population increases over the next 3-5 years and as a destination for children, families, and individuals of all ages, we need to be prepared to meet those needs and assist in protecting the health of our community. The safety of our members, participants, visitors, and community in general is of utmost importance. This is the number one reason for several of our initiatives. The water park and whirlpool resurfacing, security camera system upgrade, and the parking lot repairs and pavement are critical for us to provide and safe environment to benefit the public. Also, the building of a concession stand and bathrooms will provide an accessible restroom option for our program participants, visitors, and community members.
