project will add 13 spaces along with a crosswalk from the Murrells Inlet Bike Bridge. This area also aligns with the vision for greater access to the East Coast Greenway. although technically parking has been prohibited. The area is not presently graded safely nor is traffic access managed. This creates an unsafe condition for unauthorized parking and citizens using it for access to the path. To improve recreational access and pedestrian and cyclist safety, this area is being officially converted into parking with construction anticipated in Q4 2023. This The area adjacent to Highway 17 Business, across from the Murrells Inlet Bike Bridge, has been used for years by people as parking. Locally it's been referred to as the Bike Bridge Parking lot,
