Veterans in and near the Towns of Hollywood, Meggett, Ravenel, Adams Run, and Edisto Beach as well as the surrounding areas are way underserved by any Veteran support network. The closest VA counseling in an hours drive away in North Charleston. Benefits counseling is an hours drive as well. Not every Veteran has the means to easily reach North Charleston—either due to transportation issues, their job or their physical condition. Post 145 has three members who have recently been trained by the Amerixcan Legion as Service Officers(to assist Veterans in VA benefits applications) in order to try to address the lack of local Veteran support. We also have a current agreement with the VA to host both counseling and benefits support to area Veterans on a limited basis at the Post Business facility (Legion business, and absolutely no commercial activities are conducted there). Our current facility is not configured to support the privacy such counseling requires, nor can it be easily changed to do so. We have acquired access/use of the adjacent half of our current building in order to provide a Resource Center for Veterans in our end of Charleston County, southern Dorchester County and eastern Colleton County with a more convenient location to receive VA counseling and benefits counseling and application. When the Resource Center is fully ready for occupancy, and with the help of local mayors (who are all onboard with the Resource Center purpose), we expect to see many Veterans use the Center and the VA free counseling services for military related issues to service members, Veterans, National Guard and Reserve components: PTSD, MST (Military Sexual Trauma), family counseling and bereavement services for families who experience an active duty death. They will also be assisted with VA enrollment, scheduling, benefits questions, referrals to community resources and other Veterans services through VA outreach program specialists and our Legion Service Officers.
