Please explain how these funds will be used to provide a public benefit:

The Lindsay Pettus Greenway is a planned 6-mile system of multi-modal trails connecting points of interest throughout the City of Lancaster, SC. It is a component of the Carolina Thread Trail, a regional trail system connecting the 14 counties surrounding Mecklenburg County and Charlotte, NC. In 2020, The Lindsay Pettus Greenway opened its first two miles of trail along Gills Creek in the City of Lancaster. The current trail connects residential neighborhoods to four school campuses, parks, retail businesses, govenment services, and other critical destinations. The trail is hard-surface trail, 10 feet wide, and provides an alternative means of non-motorized transportation to destinations throughout the community to non-drivers or those without access to a reliable vehicle. In addition to an alternative transportation facility, the trail is a recreational facility, providing runners, walkers, and cyclists a safe place to exercise outdoors away from traffic. These funds will be used to further expand the trail. The entire trail system has been planned and permitted and is shovel-ready. Future segments will connect to USC Lancaster and the YMCA, the MUSC Lancaster hospital campus and nearby healthcare providers, the Lancaster County Recreation Department's recreation center and soccer complex, and additional residential neighborhoods. The Lindsay Pettus Greenway, Inc. (LPGI) is a non-profit whose mission is to raise the funds for and construct the trail system. The trail system is constructed on trail easements acquired by the LPGI from property owners. After construction, the LPGI assigns the trail easements to the City of Lancaster, which operates and maintains the trail as part of its parks inventory for the benefit of residents and visitors alike.
