<p>OUR MISSION IS TO SAVE THE CRITICALLY ENDANGERED SOUTH CAROLINA STATE HERITAGE HORSE IN ITS HISTORICALLY NATIVE HABITAT ON DAUFUSKIE ISLAND THROUGH EQUINE ORIENTED PROGRAMS THAT BENEFIT THE PUBLIC. WITH THE STATE FUNDS TO BE RECEIVED, WE WILL:</p> <p>A INCREASE THE NUMBER OF HORSES SERVED FROM 6 TO 9, WE WILL DECREASE OUR RISK OF LIABILITY, THE RISK OF OUR HORSES' AND THE PUBLIC'S SAFETY BY 50-125%, WE WILL REDUCE OUR MONTHLY OVERHEAD EXPENSES IN HAY AND POWER BILL BY 33-50%, WE WILL INCREASE THE NUMBER OF REVENUE GENERATING EDUCATIONAL AND SPECIAL EVENTS PROGRAMS BY AT LEAST 3, WE WILL IMPROVE OUR HORSES' GRAZING HABITATS TO MAKE THEM MORE LIKE THEY WERE HISTORICALLY, WE WILL ENGAGE WITH AT LEAST 20% MORE TOURISTS AND VISITORS EACH MONTH, AND WE WILL INCREASE OUR DONATIONS, MEMBERSHIPS AND NEWSLETTER SUBSCRIBERS BY 20%.</p>
