AMENDED CERTIFICATE OF INCORPORATION TOWN OF CHERAW

WHEREAS, the Town of Cheraw is a municipality incorporated under the laws of the State of South Carolina, with its original commission issued on December 20, 1820; and

WHEREAS, on December 17, 1841, the Town of Cheraw was re-incorporated pursuant to Act 2846 of 1841, and on December 21, 1854, the South Carolina General Assembly revived and extended the Act incorporating the Town of Cheraw, with the town to have and enjoy all the rights, powers, and privileges heretofore granted; and

WHEREAS, an ordinance was filed with the Secretary of State on July 20, 1976, setting forth the name of the municipality as Cheraw, S.C. and the form of government as Mayor-Council, and the Secretary of State issued the municipality a Certificate of Incorporation with the privileges, powers and immunities, and subject to the limitations prescribed in Act No. 283 of 1975;

WHEREAS, on November 8, 2022, the Town of Cheraw held a referendum pursuant to Section 5-5-20 of the South Carolina Code of Laws, 1976, as amended, to change the form of government from Mayor-Council to Council-Manager, which was approved by a majority of voters; and

WHEREAS, on November 15, 2023, a certification of election was filed with the Secretary of State indicating that the Town of Cheraw had changed its form of government from Mayor-Council to Council-Manager.

NOW, THEREFORE, I, Mark Hammond, Secretary of the State of the State of South Carolina, by virtue of the authority vested in me by Section 5-5-30 of the South Carolina Code of Laws, 1976, as amended, do hereby issue to the municipality of the Town of Cheraw this amended Certificate of Incorporation, with all the privileges, powers, and immunities, and subject to the limitations prescribed in Act No. 283 of 1975.
