Appropriation Summary Upstate Greenways and Trails Alliance- Swamp Rabbit Trail June 27, 2024

The Upstate Greenways and Trails Alliance was awarded a \$500,000 appropriation grant from the State of South Carolina in FY22-23 for project development and construction of the 2-mile Travelers Rest Greenway. The Upstate Greenways and Trails Alliance had obtained land access and done preliminary design of this new greenway trail connecting various neighborhoods, schools, and other amenities to downtown Travelers Rest and the broader Prisma Health Swamp Rabbit Trail network. Since obtaining the State funding appropriation, UGATA completed all design and permitting of this trail, and partnered with the City of Travelers Rest and Greenville County to secure all needed funds for construction. Construction is currently underway, and is being managed by Greenville County, with a projected completion date no later than December 31, 2024. All appropriation funds have been spent in accordance with the appropriation budget (see final quarterly financial report attached).

UGATA was able to use its State appropriation to leverage \$1.8 million in local funding, more than tripling the State of South Carolina's investment in this project! Once opened later this year, we expect the TR Greenway to see well over 75,000 annual uses from local residents who will take advantage of the trail to get to work, school, and recreation. We are grateful for the support of the State of South Carolina as we work to expand the benefits of trails and greenways to more Upstate residents.
