### Please explain how these funds will be used to provide a public benefit:

Conway proposes to construct a floating dock and trail from the existing trail's end at the Riverwalk, and ending at Waccamaw River Park. This trail would incorporate ADA-compliant docks with a wheelchair lift and feature a boat to transport pedestrians and cyclists across the Waccamaw River, connecting the downtown riverfront with the land across the river. The river width is approximately 300' at the proposed crossing. Once on the other side, approximately 5,000 linear feet of boardwalk would comprise the trail through the woods and wetlands to Waccamaw River Park. The boat will be captained with a unique and Conway themed approach.
