Byerly Park is the City of Hartsville's largest recreational park within the city limits serving both city and county residents. The park consists of an indoor gym, outdoor basketball court, tennis courts, football fields, baseball/softball fields, playground equipment, dog park, and outdoor walking trail. The outdoor walking trail has not been resurfaced or repaired in many years with some areas posing safety hazard for pedestrians. Correcting these areas would increase safety to users and mitigate trip hazards. Repairing the damaged areas benefit the public by increasing safety and providing an enjoyable path for users to exercise. Members of the public would be able to continue to walk this area for enjoyment and exercise while also providing an opportunity for non-residents to utilize the area during the many tournaments which are hosted at the park.
