### Please explain how these funds will be used to provide a public benefit:

Patriot Park has an annual visitation rate of over 300,000 patrons. Sporting events such as baseball, softball, and soccer have been the primary sources for our programmed travel tourism.

Other amenities such as a 4,000 sq. ft. pavilion are used for conferences and other social events. Passive activities such as a playground and the extensive 4-mile trail system have enhanced the quality of life for Sumter, Shaw Air Force Base, and surrounding communities. With this proposed project, we can add a quality outdoor venue to increase the variety of performing arts. The proposed project will consist of a large elevated permanent outdoor performing staage, hard surface, and grass syle seating areas ofr up to 7,000 attendees. Also included are multiple restroom facilities, ticket facilities, and strategically placed VIP seating areas. A paved parking lot will be built, as well as overflow grass parking that can be used for other recreational purposes.
