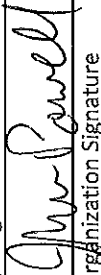

**Please explain how these funds will be used to provide a public benefit:**

The Southeastern Wildlife Exposition (SEWE) is a three-day event held each February in Charleston, SC. The mission of SEWE is to create awareness and positively influence wildlife conservation through art and specialized programming; and to continue to impact the local and statewide economies. As the largest event of its kind in the nation, SEWE incorporates all things related to nature and wildlife to be displayed and discovered by an average of 35-40,000 attendees at venues throughout downtown Charleston. With its wide array of offerings, including world class art, lectures, wildlife viewing and demonstrations, SEWE is unique to Charleston and the region with its size, scope, and access granted to attendees of all income levels. The economic benefits of the Southeastern Wildlife Exposition are staggering. While the region feels the effects of a \$35+ million impact, the local and state governments have a net tax impact of nearly \$2.8 million. The ability to generate this type of spending and impact on the regional economy while simultaneously promoting arts and nature education is one of the reasons why this event is so unique. The economic impact over the life of SEWE registers in the hundreds of millions.
