## Please explain how these funds will be used to provide a public benefit:

We are seeking to restore and rehabilitate the Historic Chapel to its 1874 appearance and condition correcting years of accumulated deterioration. Built in 1853 and purchased in 1874 by nine formerly enslaved persons, it was recently added to the Historic Registry, is one of eleven antebellum structures and one of two in the Historic Bluffton District. A significant part of the city's history, its completion will allow it to be used as an educational and cultural hub for the community. It will provide an additional venue space for the town of Bluffton, its residents and visitors to host dialogues, lectures, destination weddings, concerts, and other events that bring people together to learn and experience the unique culture of the city inspiring generations to come.
