These funds will be utilized to further develop the Mary H. Wright Greenway, specifically the addition of an outdoor classroom and gathering area. The project will include the intallation of a parking lot, promoting visitation to the newly constructed Southside Cultural Monument as well as direct access to the Greenway itself. Just below the parking lot and Monument will be an outdoor classroom, providing a gathering area for events and respite from use of the Greenway's trail. An interactive kiosk will offer visitors convenient access to a variety of information, including details of the surrounding neighborhoods. Enhancements to the area will increase its visibility and aesthetic appeal, including upgraded sidewalks, landscaping, improved lighting, and the addition of a fountain. Allocated funds include support for community outreach to ensure local residents' voices are reflected in the finalized design.
