Some of the funds from this period was used to purchase various historical artifacts, such as pictures, papers, interview records and other special historical documents displayed in the SC Civil Rights Museum. The artifacts note historical events that have transpired and impact experienced by African American South Carolinians. The remaining funds were used to organize, coordinate, implement, and operate the activities of the museum. These funds aided in the: 1. approximate 40% increase in visits to the museum; 2. increase in presentation of programs in the museum and around the State; and the 3. collaboration between the museum and several state agencies.
