Please note the Fiscal Year 2025 Expenditures totals reported in the chart above are accurate as of May 31, 2025 and are provided to comply with this report's due date of June 25, 2025. Final and complete Fiscal Year 2025 Expenditures totals will not be available until July 31, 2025 as the City's fiscal year ends on June 30, 2025. **Cultural Corridor/Academy Bypass:** Construction underway, EST complete by Fall 2026: Expenses to date include design services, traffic analysis, and construction activities. These expense activities support achieving the overall project goal to complete a streetscape with extra wide sidewalks and a landscaped curb lawn on SC-183 between N. Main Street and the cultural facilities at Heritage Green. Construction on this project is 80% complete. The project also completed several congestion relief projects along Academy Street to encourage through traffic to bypass the Central Business District. **Wade Hampton Corridor Safety Improvement:** Design underway, EST construction complete by end 2026: Expenses to date include planning services, design services, survey services, traffic analysis and preconstruction activities. These expense activities support achieving the overall project goal to complete construction on the first two phases of the Wade Hampton Boulevard safety project. Phase 1 of the safety project includes intersection improvements, access management, and a realignment of Bradley Boulevard to better align the roadway with Wade Hampton Boulevard. Phase 2 includes roadway safety improvements, medians, intersection improvements and traffic signal improvements. **Queen Street Bridge Design Phase 1:** Design complete: Expenses to date include planning services, design services, and survey services. These expense activities support achieving the overall project goal to identify a conceptual replacement plan for the Queen Street Bridge. A conceptual plan will result in an alignment and expected construction costs of the project. **Pedestrian Safety Action Plan:** Construction underway, EST construction complete by Fall 2025: Expenses to date include planning services, design services, survey services, and construction activities. These expense activities support achieving the overall project goal to complete construction on the first two phases of the Pedestrian Safety Action Plan implementation in school zones and the selected top corridors identified in the study. Phase 1 construction activities are complete and Phase 2 construction is 75% complete. **E. North Street Gateway Design:** Design complete: Expenses to date include planning services, design services, survey services, and traffic analysis. These expense activities support achieving the overall project goal to complete a final streetscape design for E. North Street that enhances economic development opportunities and increases pedestrian safety around the Bon Secours Wellness Arena. **Pendleton/Vardry Intersection:** EST construction complete by Summer 2025: Expenses to date include planning services, design services, survey services, traffic analysis and construction activities. These expense activities support achieving the overall project goal to complete construction on an intersection improvement project at the intersection of Pendleton Street/S. Main Street/Vardry Street. Project will be completed in conjunction with a road diet along Pendleton Street focusing on vehicular and pedestrian safety. Construction is 85% complete. **Augusta Street Utility Undergrounding:** Design & ROW Acquisition underway, EST construction completion date by end 2026 is still on schedule. Expenses to date include planning services, design services, and survey services. These expense activities support achieving the overall project goal to complete a utility undergrounding project along Augusta Street between Catechee and Faris Road Utility undergrounding can provide reliability enhancements as well as safety improvements when existing power poles are located too closely to the roadway. Undergrounding efforts are being designed in conjunction with the city's current plans for streetscape upgrades to the same corridor. 75% construction plans are completed. Anticipate construction to start in Fall of 2025. **Stone Avenue Corridor Safety Improvements:** EST complete by Spring 2025: Expenses to date include planning services, design services, survey services, traffic analysis and construction activities. These expense activities support achieving the overall project goal to complete a construction project on Stone Avenue to implement the short-, mid-, and long-term recommendations from the recent Roadway Safety Audit that was completed along the roadway. Project enhanced pedestrian safety along the corridor, identified future long-range planning efforts, and is 95% complete on installation of a new PHB signal for safer pedestrian crossings of the roadway.
