The first and foremost goal that was attained was the safety issue for the members of the Community Center who used to have to climb a ladder to change letters on the previous sign to announce events. We have received positive feedback from the community in that we are now able to provide advance notice of multiple activities that are occurring at the Community Center instead of just one. Many people were not even aware that the building was being used, much less the number of classes that are offered or the services that we provide to the community.
