Allocated funds have been used to enhance the Southside Cultural Monument site along the Mary H. Wright Greenway, incorporating improvements such as an outdoor classroom, benches, a water fountain, security systems, and landscaping. The Monument has become a frequent stopping point for individuals, families, and children, providing a space to learn and reflect.

The completed enhancements have maximized the site's potential for community use and engagement, with a significant increase in the site's value, visibility, and overall appeal. Designed to serve as an educational, historical, and celebratory community art piece, the space now fosters cultural vitality, encourages community participation, and promotes trail usage. Its unveiling attracted over 400 attendees, while the Monument continues to draw visitors during the day and evening, when it is illuminated. The outdoor classroom and kiosk have further enriched the learning experience by offering organized seating and technological resources, particularly for youth and community tours.

Community outreach initiatives and educational tools, such as an accompanying booklet, have been instrumental in enhancing the learning opportunities and accessibility of the site. The momentum generated by the unveiling, coupled with these thoughtful enhancements, has revitalized the space and established a foundation for sustained community engagement and cultural impact.
