

| <p>The Cecil Williams South Carolina Civil Rights Museum is the first and only civil rights museum in the state of South Carolina. Visitors to the museum will gain a better understanding of the role of South Carolina during the Civil Rights era. Using the extensive collection for presentations in schools will enhance the knowledge of the students in South Carolina about the history of the civil rights in South Carolina. Moving into phase two of the 36 previous months of operation, the museum will now expand its exhibits and displays to attract additional regional and statewide visitors along Interstate 26 to exit into Orangeburg at exits, 145, 149, and 154. Print and digital ads will promote the museum and its exclusive historically significant artifacts, documents, and photographs. In addition to the museum's impressive collection of events throughout South Carolina, special emphasis is given to the Orangeburg Massacre, and the Clarendon County Briggs v. Elliott petitioners; already the largest exhibits anywhere have been curated at the museum. Part-time director and manager will enable museum to achieve flexible working hours to attract visitors without appointments. A qualified historian/consultant will enable the museum to continue to interpret, and curate artifacts and documents.</p> | |

*WHEREAS, the municipality of the City of Orangeburg, S. C.,
is incorporated under the laws of the State of South Carolina.*

*AND WHEREAS, a charter has been issued to the above municipality of
the City of Orangeburg, S. C. (August 10, 1904).*

*AND WHEREAS, Section 47-26 of the 1962 Code of Laws, as amended,
requires that all municipalities to adopt a specific form of government.*

*AND WHEREAS, an ordinance was filed with the Secretary of State on
October 10, 1975, setting forth;*

FIRST: The name of the municipality is the City of Orangeburg, S. C.

*SECOND: The form of government adopted is Council
form of government.*

*NOW THEREFORE, I, O. Frank Thornton, Secretary of State, by virtue
of authority vested in me by section 47-28 of the 1962 Code, as amended,
do hereby issue to the municipality of the City of Orangeburg, S. C.,
this Certificate of Incorporation with the privileges, powers and
immunities, and subject to the limitations prescribed in Act. No. 283 of
1975.*
