Please explain how these funds will be used to provide a public benefit:

Historic Randolph Cemetery was created in 1872 as the capital city's first private burial ground for African Americans. It is the final resting place of about a dozen Reconstruction-era legislators, as well as hundreds of people from all walks of life in Columbia's black community from the 1870s through the 2000s. It honors the late state Senator Benjamin F. Randolph, assassinated in 1868 as part of a rash of political violence against white and black Republicans. this site is important to the state's political and social history and is open year-round for anyone to visit. The funds will be used to keep the grass cut, which is very important in making the site more safe and welcoming for visitors. The funds would also be used to restore some headstones, remove invasive shrubs or trees, repair the road, and stop erosion at the east entrance. These funds will help keep this site in good repair and allow the public to continue to enjoy this historic site.
