Please explain how these funds will be used to provide a public benefit:

The primary goal of the "Community-based Oyster Shell Recycling and Bed Restoration" project was to initiate a grassroots, community-wide oyster shell recycling program on HHI for the purpose of returning this shell to the ecosystem through reef and shoreline restoration projects. The Town of Hilton Head Island, it's residents and visitors, all directly benefit from this program through (1) oyster reef building projects which protect our vulnerable salt marshes and coastal shorelines (2) creation of new habitat for the SC fisheries industry, (3) a more cost effective way to protect against coastal erosion through the construction of "living shorelines" and (4) opportunities for all ages to engage in "hands on" environmental sustainability. If supported this community-based effort will become a statewide model program for cost effective management of shoreline erosion and maintenance of fisheries habitat through the cooperative efforts of the private section with local, regional, and state level government. Overall we seek to use this funding to create a model, community-based, oyster shell recycling and bed restoration program on Hilton Head Island to both protect our vulnerable coastline and be shared with other Southeast Atlantic coastal communities which face similar environmental threats.
