Please explain how these funds will be used to provide a public benefit:

Pickens and Northern Anderson Counties have limited resources for childcare and modest options for early learning (pre-kindergarten), especially for low-income families. While there is a significant need for safe, reliable childcare, data also shows that only 27% of children in Pickens and Northern Anderson Counties demonstrated readiness for Kindergarten according to the 2021 KRA report.

In the fall of 2020, our YMCA began an ambitious goal of constructing three Child Development and Training Centers (CDTC) to help meet the critical early childhood needs in Easley, Pickens and Powdersville communities, as funding allows. Each CDTC will serve approximately 200 children, infant to 5 years old, with a specified number of subsidized spots for families in need. Funds from the State will support the YMCA's work toward this goal.
