This request is to renovate the South Sumter Park. The park is approximately 5.5 acres located in South Sumter in a low to moderate income area. This project would allow the City to breathe new file and activity in an underserved area. The park will include modern accessible playground equipment, gazebo and shelter area, outdoor exercise area, walk ing track, restroom fac lities, grading, paving and new landscape, parking lot, tennis/pickleball court, and brick and iron fencing. This parcel is owned and maintained by the City of Sumter and received \$500,000 in state grants in 2021 to begin this process, however these funds would allow the park to be completed.
