Please explain how these funds will be used to provide a public benefit:

CMA is the premier art museum of SC, located on Main Street in the heart of downtown Columbia, and home to an internationally renowned collection of more than 7,000 pieces of art spanning 5,000 years of global history. Holding and caring for these objects and exhibiting them for the enjoyment of our community and visiting tourists, requires precise temperature and humidity ranges to ensure compliance with industry standards for the preservation of art works. Acute changes in the environment can cause swelling and contraction in the materials, leading to damage, and sophisticated air handling units are the best protection against these issues. Much of the system is original to construction of 1998. Similarly, the existing track lighting to be assessed with these funds is original to construction and obsolete. It limits CMA's ability to utilize recent innovations in more efficient and environmentally conscious lighting elements, as well as our capacity to adapt the lighting to better enhance the experience of our guests and visitors. CMA welcomes in excess of 100,000 guests annually to exhibitions and programming, from gallery talks and traveling exhibition receptions, to a wide and varied range of musical offerings and other art-related activities, annual fundraising events, and more, and we welcome the opportunity to increase both activity and attendance going forward. An assessment of our current lighting and a site-specific design plan for upgrade will provide the data we need to build an environment that matches the quality of the world-class art and diverse programming we are proud to offer to the public.
