The funding has allowed us to make visits to the Cecil Williams South Carolina Civil Rights Museum free to the general public. During this fiscal year today we have had more than 5,000 visitors to visit. In addition with support from the South Carolina Arts Commission we have been able to distribute approximate 10,000 posters to schools and community organizations. Further, we have been able to purchase much needed equipment, materials, supplies and acquire artifacts for the museum. This funding has allowed us to be able to tell the story of the vast contributions of South Carolinians and to help everyone understand the importance of the Briggs v Elliott school desegregation case to the nation.
