Detailed Spending Summary: We have not spent any of the state granted funds to date. We are in the middle of the design and property accusition phase for the Greenway. There are state funds in the budget for property accustion, but they won't be executed until the end of the phase, targeted for later this calendar year. The rest of the state funding is budgeted for construction and asset purchasing. Goals That Were Accomplished: We kicked off the project and aquired a A/E Team to work with us and property owners to develop the design. We have been working through this and are currently in the process of marking the center line of the proposed trail. Prior to this, we developed a proposed path based on SCDNR TOPO maps, so we could ensure our route could be constructed to be ADA compliante. How the Expenses Benefit the Public: Once the project is complete, we feel this could not only be a means of leisure, a connection to nature, an alternative transportation route throughout the midlands, but also an identy and brand for the local community. Yet to Start Explanation: We have begun the project, but we have not begun to spend these dollars. The design funding is coming from a different source.
